## AREAS OF SERVICE// CAPACITY BUILDING

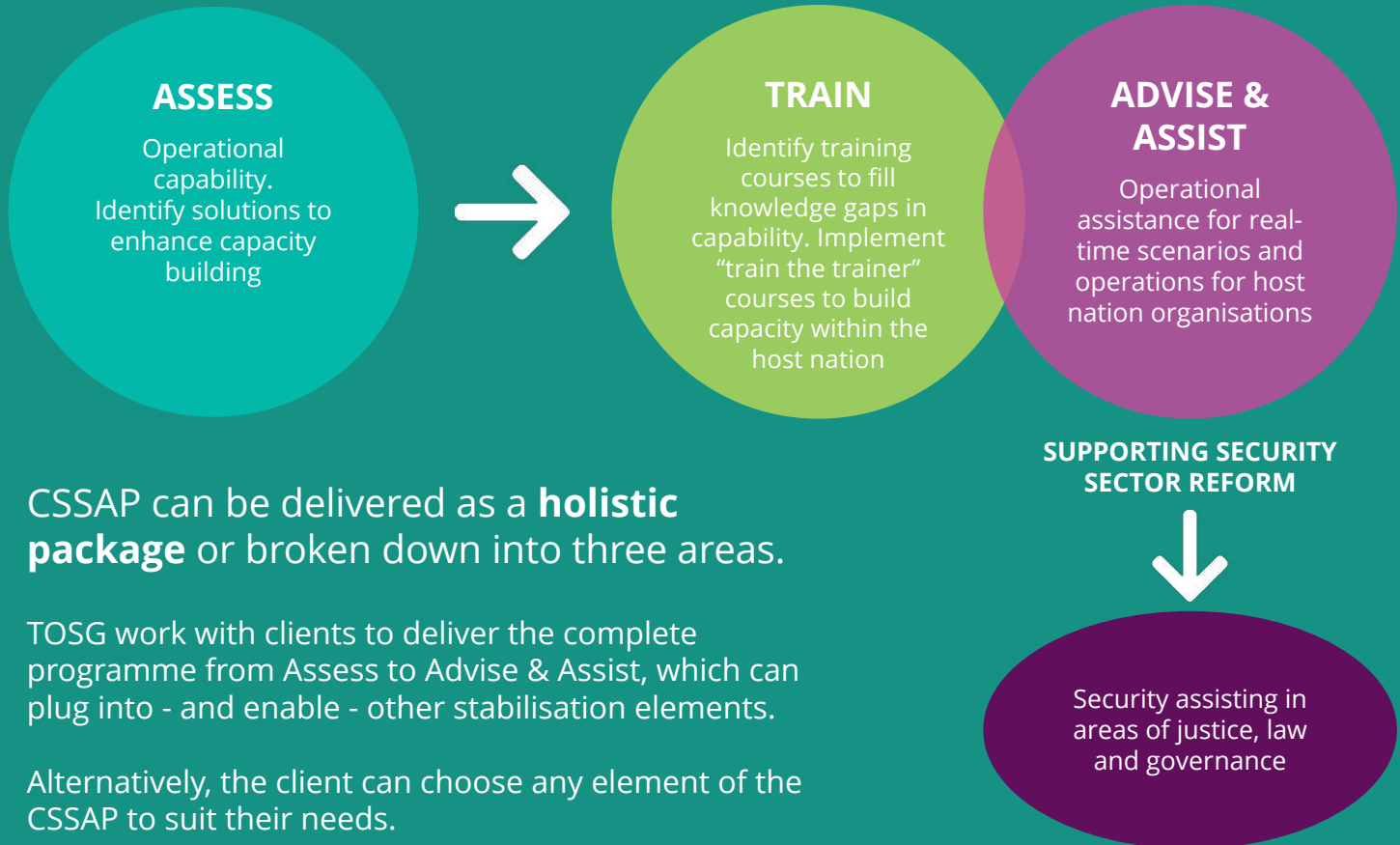
TOSG create a **customised service** for every scenario.
